北京国医械华光认证有限公司(Beijing Hua Guang Certification of Medical Devices Co. Ltd. 简称"CMD")成立于2002年。前身为1994年经原国家医药管 理局批准成立的"中国医疗器械质量认证中心",是一家由国家认证认可监督管理委 员会批准(批准号: CNCA-R-2002-047),具有医疗器械管理体系认证、医疗器械 产品认证资格的并经官方认可的专业性认证机构。CMD按照中华人民共和国法律 成立并经工商登记注册,是具有独立法人地位的第三方认证机构,服务对象覆盖医 疗器械全生命周期产业链所涉及的各类组织和外部供方。

Beijing Hua Guang Certification of Medical Devices Co., Ltd. (hereinafter referred to "CMD") was established in 2002, the predecessor of CMD was "China Medical Device Quality Certification Center" approved by the former National Medical Administration in 1994, which is also approved and accredited by official authority as professional certification body with qualification of QMS and Product Certification referring to Medical Devices (Grant No.: CNCA-R-2002-047).
